SENIOR SUBSCRIPTION POLICY 2024-25

1. SUBSCRIPTION POLICY OVERVIEW:

Subscriptions are set prior to the AGM by the Eastern Mavericks Management Committee and are ratified at the AGM. The Policy is displayed on the Eastern Mavericks website.

To be successful in any sport everyone needs to buy in and be part of the team or organisation - being a paid-up member makes you part of that team.

2. SCHEDULE OF FEES 2024-25:

Subscriptions are set for the period from the 11 August 2024 to August 2025

Pre-season

Subscription Fee

- Youth District League \$130.00
- Senior District League \$130.00
- Reserves \$130.00

An invoice will be raised for the pre-season for all senior players.

Championship Season

Subscription Fee

- Youth District League \$235.00 + \$100 (Volunteer levy)
- Senior District League \$235.00 + \$100 (Volunteer levy)
- Reserves \$235.00 + \$100 (Volunteer levy)

NBL1 CONTRACTED PLAYERS DO NOT PAY Subscriptions for the Championship Season, provided they secure a player/bronze sponsor.

Affiliation levies are now paid separately by the member upon Self Registration. The affiliation levies cover Basketball Australia Levy, Basketball SA Levy [Registration and Insurance] any CPI increases.

NOTE 1: EXEMPTIONS Volunteer Levy: Members exempt from the volunteer levy include: Committee members, Team Managers and Coaches.

NOTE 2: Senior players who take on an official role within the **CLUB** for an entire season will be eligible for a fee reduction or waiver, at the discretion of the senior committee.

NOTE 3: Any financial junior player, playing in the senior program is not required to pay senior subscriptions

Full payment is required within 30 days as from date stated on the invoice. Failure to pay within 30 days will mean that player is deemed UNFINANCIAL and not eligible for selection.

Unfinancial Players

- Players who do not pay their subscriptions or default on the agreed direct debit shall be ineligible to play, and they will be reinstated when all outstanding debts have been settled.
- Unfinancial players shall be notified in writing by the Eastern Mavericks Basketball Club informing of their exclusion from playing and amount owing.
- The relevant Coach and Team Manager will be notified of the player exclusion from future games, in accordance with this policy to assist with enforcement.
- Unfinancial players will not be eligible to receive any club awards until all outstanding fees are paid in full.
- Unfinancial players shall not be included for future team selections unless all outstanding fees have been paid prior to trials.

PAYMENT OPTIONS

Option 1: Lump sum payments.

Full payment is required within the timeframe indicated on the invoice

.Method of payments: EFT Transfer, Credit Card payment. When EFT Transfer payment is used, the player must include the Invoice No and Player Surname.

Option 2: Monthly Direct debit via Club nominated software (Self-appointed payment plans are not available)

The Eastern Mavericks District Basketball Club recognises that some players may find difficulties in paying fees in full by the nominated due date via lump sum payments. It is not the intention of the club to prevent players taking part in basketball activities, therefore the club will accept a payment option via the agreed Direct Debit software to assist those in need. Families choosing this option will need to ensure that the outstanding fee balance is finalised by the last minor round of the relevant season. If a payment default occurs during the payment plan period the player will be deemed unfinancial and not considered for selection for playing until full payment has been made.

GENERAL SUBSCRIPTION INFORMATION

Uniform Hire:

- Coaches Polo tops not returned after their contract ends will be invoiced for the cost of replacement.
- Any uniform items for NBL1 Players lost or damaged by the player will be invoiced for the full cost of replacement.

General Fee Information:

- All parents and players are reminded they are responsible for retaining the receipt of any payments; the club accepts no responsibility for lost receipts, this is especially relevant for cash payments.
- Players who start part way through a season will be charged subscriptions pro rata; however, the affiliation and insurance levies will be at full cost.
- Any players choosing not to continue for the full year of subscription will not be refunded their subscriptions nor will there be pro rata.
- Any long-term injuries affecting a player's ability to play will be dealt with on an individual basis by written application to the Committee:



General Fee Information (cont.):

- Players that stop playing during a season shall not be entitled to any refund unless they meet all of the following criteria:
 - They have been injured and are unable to play for the remainder of the season
 - The injury has occurred before or on round 5
 - A doctor's certificate is received by the Committee
- If a player wishes to transfer to another club any outstanding fees must be paid in full and any club apparel items that belong to the club returned in good condition. In addition, a \$50 administration clearance fee must be paid before the Eastern Mavericks Basketball Club finalises and grants the player clearance.
- All Carnivals and other tournaments will be at an additional cost. Charges are required to be paid before the tournament begins.
